The Slovenian Journal of Public Health is committed to maintaining high standards of editorial practice, publication ethics and scientific integrity. The journal follows internationally recognized principles of scholarly publishing, including the recommendations of the International Committee of Medical Journal Editors (ICMJE), the principles of the Committee on Publication Ethics (COPE), the Declaration of Helsinki, and applicable legislation and ethical standards for research involving humans, human material, human data or animals.

SHORT DESCRIPTION OF THE SLOVENIAN JOURNAL OF PUBLIC HEALTH

The Slovenian Journal of Public Health / Zdravstveno varstvo has been published since 1962 by the National Institute of Public Health in Slovenia. Since 2003, the journal has been a peer-reviewed scientific journal with English abstracts, and since 2014, an international scientific public health journal in English only. The journal's mission is to promote new achievements in the broad field of public health in Slovenia and Central and South-East Europe. The journal publishes internationally oriented articles and encourages an interdisciplinary approach to public health. The journal is a source for exchanging new public health concepts and solutions among researchers. The journal mainly publishes original scientific articles, and on occasion also systematic reviews, methodological articles, and invited editorials. It is published four times a year, with up to 35 articles each year, and has an average annual rejection rate of around 80%. The journal is indexed in major international databases, such as PubMed, Web of Science, and Scopus, and has had an impact factor since 2011, ranging from 0.16 to 2.5. As an open-access journal it is available online on Paradigm Publishing Services <https://reference-global.com/journal/SJPH>.

RESEARCH DATA PREPARATION AND DEPOSITION

Before manuscript submission, prepare your research data (anonymized and ethically edited) and deposit them in a recognized digital repository, such as, but not limited to, DiRROS (Digitalni Repozitorij Raziskovalnih Organizacij Slovenije), the EU-funded research repository Zenodo, Dryad Digital Repository, Open Science Framework, etc. Upon deposition, the repository will assign a persistent identifier (e.g., a DOI or accession number) to your dataset.

Depositing research data in trusted repositories promotes transparency, reproducibility, and the reuse of research outputs.

For articles arising from projects funded at least 50% by public sources, Slovenian regulations require that both research data and articles must be made openly accessible. Compliance with open access funder mandates is verified by the editorial office during the technical corrections phase.

SUPPLEMENTARY MATERIAL

You can deposit supplementary material (e.g., extra tables and figures) in digital repositories like Zenodo, DiRROS etc. Cite it in the manuscript and add it to the reference list as: "Supplementary material for the article [Article title]. Available at [DOI link]."

MANUSCRIPT SUBMISSION

The journal welcomes submissions in electronic form to the web-based peer-review system, Editorial Manager at <http://www.editorialmanager.com/sjph/>, and does not accept submissions by email or post.

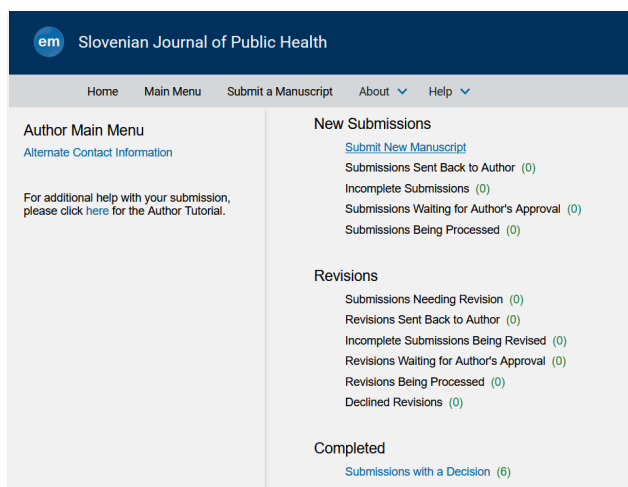
Log in to the EM application as an author ([Author Login](#)).

The first time you log in, you will need to register by entering your author data. For all subsequent logins, you will only need the login information sent to your email address after the initial login to the system.



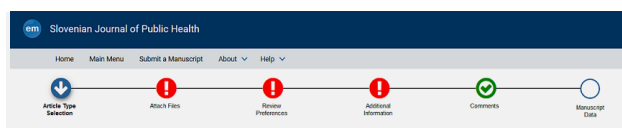
SUBMIT NEW MANUSCRIPT

After successfully logging into the system, this menu will appear. To submit a new manuscript, click on **'Submit New Manuscript'**



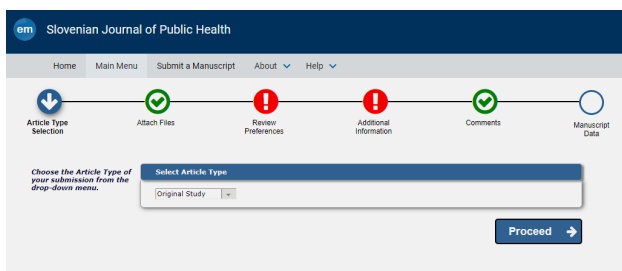
DATA INPUT

Submitting the manuscript requires the sequential input of several pieces of data: Article Type Selection, Attach Files, Review Preferences, Additional Information, Comments, and Manuscript Data.



MANUSCRIPT CATEGORY (Article Type Selection)

Choose the Article Type for your submission from the drop-down menu, then click the **'Proceed'** button.



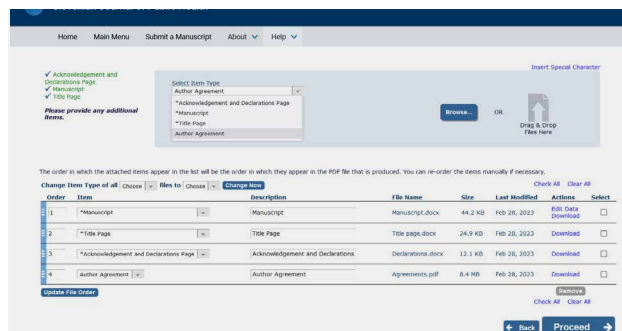
ATTACHMENTS (Attach Files)

You must then upload three Word attachments: 1) the Manuscript, 2) the Title Page, and 3) the Acknowledgement and Declaration Page.

After acceptance, the corresponding author signs the Open Access (OA) License to Publish on behalf of all co-authors. Complete the license, sign it electronically (or scan a signed copy), and return it by email to zdrav.var@njz.si in order to proceed with production. By signing the license, the authors grant the publisher non-exclusive publishing rights under the Creative Commons Attribution 4.0 (CC BY 4.0) license.

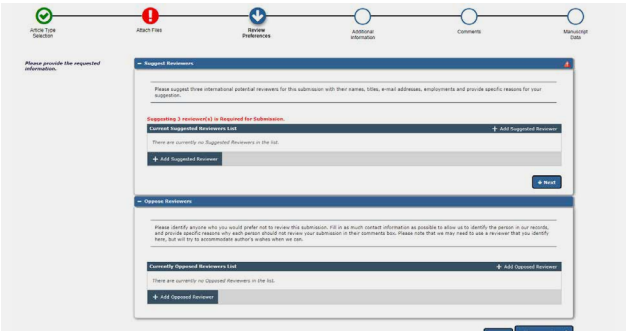

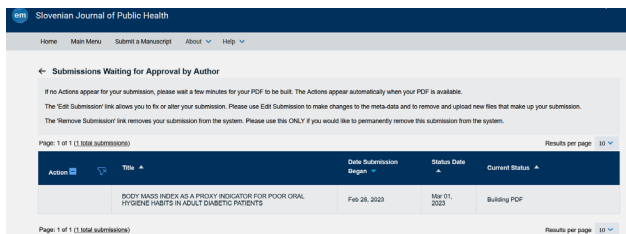
METADATA (Manuscript Data)

The metadata (Manuscript Data) are the title, abstract, keywords, and authorship. The title, abstract, and keywords are submitted in English and Slovene (the latter not applicable for foreign authors) in structured fields. There is a separate field for entering a different language only for the abstract, and the remaining data must be entered in English and Slovene (the latter not applicable for foreign authors) in the appropriate identical field in the second line. The first abstract is always in English (up to 250 words - the system counts the words for you), and the second in Slovene (extended abstract - up to 400 words). Please list 4 to 6 keywords in plural form and both languages (if applicable). If possible, align these keywords with the MeSH thesaurus. Enter the names of the authors as accurately as possible. You may reorder the authors by dragging and dropping an author's summary line to the correct position in the Current Author List. Please select a corresponding author, who will be responsible for communication with the editorial office, and the co-authors (we need the address, telephone number, and email address of corresponding author).

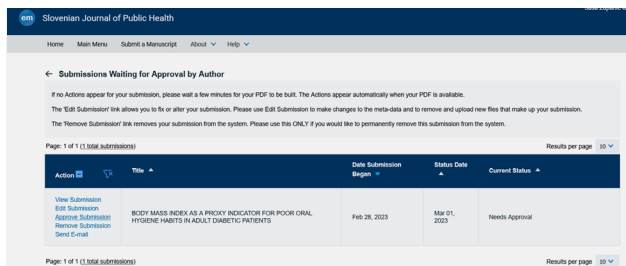

DETAILED DESCRIPTION OF THE REQUIREMENTS FOR ALL ATTACHMENTS MANUSCRIPT

The manuscript should be written in English, and UK spelling is preferred. The manuscript file name must not contain the authors’ personal information or the names of the institutions involved in its preparation.

Required length for invited editorial is 1,000 to 2,000 words, for research article 2,000 to 4,500 words and for systematic review article 2,000 to 6,000 words with tables, figures and references. The revision may have 5,000 words for research article and 6,500 for a systematic review article.

The manuscript should be prepared using Microsoft Word for Windows. Set all margins to 25 mm, use Arial font in 12-point size, line spacing 1.2, and enable continuous line numbering. This will display a line number in the margin for each line of the manuscript, enabling reviewers to refer to specific passages in their comments.

The manuscript should include the following sections: Introduction, Methods, Results, Discussion, Conclusions, and References. Invited editorials may follow a different structure. Main headings should be presented in uppercase bold type, whereas subheadings should be presented in lowercase bold type. Sections and subsections should be numbered using a decimal system (1, 1.1, 1.1.1). Please use Microsoft Word’s built-in heading styles—Heading 1, Heading 2, and Heading 3—to clearly distinguish between

headings and subheadings. Also, please use built-in bullet or numbered lists.

Avoid abbreviations and acronyms, except for internationally recognized unit symbols. If an abbreviation is used, write the term in full at its first occurrence in the text, followed by the abbreviation in parentheses; use the abbreviation alone thereafter. Units of measurement should be in accordance with the International System of Units (SI).

Include all graphic material, including tables and figures, in the main text at the appropriate locations. Each table and figure should have a clear title and, where necessary, a legend explaining any abbreviations or symbols.

Keep tables simple, avoid merged/split cells, and add header rows.

Figures should be presented in black and white on a white background for the print edition of the journal; colour figures with good colour contrasts may be used in the electronic edition. All letters, numbers, and symbols must be clear, consistent, and sufficiently large to remain legible when the figures are reproduced at a reduced size. All figures, charts, and other non-text elements must include concise and informative alternative text (alt text) to ensure accessibility. The alt text should describe the essential content or purpose of each element and should not merely repeat its title or legend.

Hyperlinks (not in References section) should be presented using descriptive text rather than as raw URLs.

References: The journal follows the Vancouver numerical referencing with DOIs commonly used in biomedicine. Formatted citations should be numbered consecutively in a reference list as they are cited in the manuscript text. References cited in tables or figures legends should also be numbered to be in sequence with the references cited in the text. Please do not use the footnote or endnote feature to cite or create a reference list. Try to avoid using personal communications, unpublished data, and manuscripts in preparation as references.

In the Reference list, please cite all openly accessible research data that support the conclusions of your research. This includes novel datasets deposited in a repository alongside your publication, as well as relevant secondary data sources.

In-text citations: Each mention of the statements or findings by other authors should be cited. Reference numbers (Arabic numerals) in the text should appear in normal type and curved parentheses:

Adam et al. state that the data is ‘unreliable’ (1, p. 122).
This argument is increasingly relevant to the topic (2, 3) ...
Several studies (1, 4-8, 12) ...

Each entry starts with the author’s surname and initials. When a source has more than one author, their names are separated by commas. If a source has more than six authors, list the first six followed by ‘et al.’ Only the first word of the title and subtitle, along with any proper nouns, are capitalized. Titles in Vancouver referencing

are consistently written in plain text, without italics or quotation marks. Journal titles should be abbreviated according to the National Library of Medicine's [List of Journals Indexed for Medline](#); for unlisted journals, please provide complete journal titles. If the article/book has a DOI number, please include it at the end of the reference.

Before publishing an article in the journal, the editorial office reviews the literature list and, if necessary, corrects it. You can use a reference manager programme to cite your literature. Please choose the Vancouver citation style with DOI. When preparing the manuscript, the authors should check the Slovenian literature on the topic that was published in the last five years.

TITLE PAGE

The title page should include the following information: title, authors, affiliations, [ORCID](#) numbers of authors, email address of corresponding author, abstract, and keywords.

The title should be informative and precise, descriptive and not assertive (full sentences are not allowed in titles). The title should not contain abbreviations.

The names of the authors should be given in the order preferred, with the full addresses of the institutions where the authors are employed. Authors must meet the conditions for authorship. They must contribute to the conception and design or analysis and interpretation of the data, they must intellectually conceive of and critically review the manuscript, and they must agree with the final version of

the manuscript. Simply collecting data is not sufficient for authorship. Shared first authorship is allowed for up to two authors. Please give the ORCID numbers of the authors and the email address of the corresponding author.

The abstract should be structured in the IMRC structure and no longer than 250 words in English and 400 words in Slovenian. The abstract for invited editorials may be unstructured. The abstract should summarize the content of the manuscript, written in the third person, and avoid abbreviations and acronyms.

Between 3 and 6 keywords should be listed.

ACKNOWLEDGEMENT AND DECLARATION PAGE

The acknowledgement should be placed first in the document. It should thank all contributors who did not receive authorship of the manuscript.

The document should then include the following statements:

CONFLICTS OF INTEREST

(The authors declare that no conflicts of interest exist.)

FUNDING

(The study was financed by ...)

ETHICAL APPROVAL

(Received from the... or description of the ethical aspect of the research)

INFORMED CONSENT

(Written informed consent was obtained from all individual participants included in the study. The study was conducted in accordance with the Declaration of Helsinki.)

DATA AVAILABILITY STATEMENT

This statement must clearly specify how the data underlying the manuscript can be accessed.

If data are deposited in a repository, include direct hyperlinks and persistent identifiers (such as a DOI or accession number) where available.

If data cannot be shared openly—for example, to protect study participants' privacy—this restriction must be clearly explained.

The statement should cover both original data generated during the research and any secondary data sources reused to support the results and analyses.

All openly available research data on which the study's conclusions are based must be cited in the References.

Examples:

The experimental data supporting this study's findings are available in Zenodo at [URL].

Anonymized data collected in this research are deposited in the DiRRoS repository under accession number xxxxx and available at [URL].

Data sharing is not applicable to this study, as no research datasets were generated or analyzed.

The data used in this study are curated by the National Institute of Public Health of the Republic of Slovenia and are not openly available due to legal and data protection restrictions. Access may be granted upon reasonable request to the data holder, subject to compliance with applicable legal, institutional, and security requirements.

AI USAGE STATEMENT

Authors should only use generative AI and AI-assisted technologies (like ChatGPT) to improve readability and language of the manuscript. Authors must disclose the use of these technologies in the writing process by adding the AI usage statement.

Example:

During the preparation of this work the author(s) used [NAME TOOL /SERVICE] in order to [REASON]. After using this tool/service, the author(s) reviewed and edited the content as needed and take(s) full responsibility for the content of the publication.)

PREPRINT STATEMENT

Deposition of preprints in recognized preprint repositories, such as bioRxiv, medRxiv, and others commonly used academic preprint repositories, is allowed before manuscript submission to the SJPH, but they must not have been published or submitted elsewhere.

Authors are required to disclose the existence of a preprint in the Preprint statement. Please include the name of the preprint server and the DOI or URL of the preprint.

Example:

The preprint has been deposited in a preprint server Research Square, and is available from <https://www.researchsquare.com/article/rs-2351315/v2>.

It is also recommended to cite the preprint in a reference list. For the SJPH public comments on preprints are not acceptable as reviews.

After the submission is accepted for publication in the SJPH and before the publication, authors are required to link the preprint to the SJPH article with its DOI number. It is recommended that authors cite the final, published version of a work, not the preprint.

Research involving human subjects (including human material or human data) must have been performed in accordance with the [Declaration of Helsinki](#) and must have been approved by an appropriate ethics committee. A statement detailing this, including the name of the ethics committee and the reference number where appropriate, must appear in all manuscripts reporting research on human subjects. If a study has been granted an exemption from requiring ethics approval, this should also be detailed. The authors must explain the rationale for their approach, and demonstrate that the institutional review body explicitly approved any questionable aspects of the study. Further information and documentation to support this should be made available to the editors on request. A manuscript may be rejected if the editors consider that the research has not been carried out within an ethical framework. In rare cases, the editors may contact the related ethics committee for further information.

For all research involving human subjects, informed consent to participate in the study should be obtained from participants (or their parent or guardian in the case of minors) and a statement to this effect should be provided.

For all manuscripts that include information or images relating to individual participants, written informed consent for the publication of these images must be

obtained from the participant (or their parent or guardian in the case of minors) and a statement to this effect should be provided. These documents must be made available to editors if requested, and will be treated confidentially.

For research carried out on animals, authors are encouraged to comply with the “Animal Research: Reporting in Vivo Experiments” - ARRIVE guidelines, and must comply with local or institutional ethics approval requirements on the care and use of animals for research. A statement detailing such ethics approval and/or guidelines must be provided.

Declarations must disclose any financial or other interests of the pharmaceutical industry or equipment manufacturers and institutions associated with the manuscript.

EDITORIAL WORK

All submitted manuscripts are first checked by the editorial office for compliance with the journal’s scope (public health topics from Central and South-Eastern Europe) and technical requirements. Plagiarism is checked using Crossref iThenticate. If plagiarism is detected in the results, the manuscript is excluded from the editorial process; otherwise, authors are given the opportunity to revise the manuscript. The similarity index without references must not exceed 20%.

Manuscripts with international or significant regional public health relevance are forwarded to two editors for initial assessment. Manuscripts that meet scientific and ethical standards are then included in the peer review process.

The journal uses a double-blind peer review process. Each manuscript is sent to three independent, internationally recognized reviewers, at least one of whom must be from abroad. Reviewers are selected based on their expertise and absence of conflicts of interest with the authors or the research. Authors are required to suggest three reviewers and may exclude up to two. The editors will decide whether to invite any of the suggested reviewers.

Editors (members of the Editorial Board) may serve as reviewers only when their specific expertise is relevant and it is not possible to obtain three external reviews within a reasonable timeframe. In such cases, the Editor-in-Chief ensures that there is no conflict of interest and that the Editorial Board member is not involved in the final decision regarding the manuscript.

The editorial process is independent, confidential, and conducted in accordance with the highest ethical standards and the guidelines of ICMJE and COPE. All manuscripts are handled impartially, regardless of the institution or country of origin of the authors.

Peer Review Timelines:

Reviewers have 28 days to prepare their review.

The first editorial decision for geographically irrelevant manuscripts is communicated to authors within a few days. The time from submission to the first editorial decision for manuscripts undergoing peer review is usually about 3 months, and the time to the final editorial decision (including revisions) is between 5 and 6 months.

Authors must submit the first revised version within 2 months, and all subsequent revisions within 1 month. If the editorial team is preparing a new issue and time is limited, these deadlines may be shortened.

A maximum of three revisions is allowed. If, after the third revision, all comments are still not addressed, the manuscript is rejected.

After acceptance, the manuscript undergoes language editing in both English and Slovenian. Authors receive brush proofs for correction of typographical errors only, which must be returned within three days.

The Slovenian Journal of Public Health / Zdravstveno varstvo is an open access journal. After acceptance, the corresponding author must sign the OA License to Publish.

The journal does not charge any publication fees, and authors and reviewers are not compensated with honoraria.

All complaints or questions regarding editorial decisions or the peer review process are addressed by the Editorial Board at its meetings. Authors may contact the editorial office.
